# **Stabilization of Forest Areas**

#### **Forest Area Designation**

Of the total area of 15.3 million hectares, its designation has been determined through:

1. Based on the Regional Regulation No. 5 of Year 2015 concerning the Central Kalimantan RTRWP, stipulated:

KSA / KPA = 604,957 Ha
Protected Forest = 391.604 Ha
Limited Production Forest = 335,571 Ha
Production Forest = 896,706 Ha
Conversion Production Forest = 258,274 Ha
Other Use Areas (APL) and Waters = 629,779 Ha

2. Based on the Decree of the Minister of Forestry No. 529 / Menhut-II / 2012 dated September 25, 2012 concerning the Change of Amendments to the Decree of the Minister of Agriculture No. 759/Kpts/Um/10/1982 concerning the Appointment of Forest Areas in Central Kalimantan Province Region Level I the width of  $\pm$  15,300,000 ha (fifteen million three hundred thousand hectares) as forest areas, stipulated around 65.54% as permanent forests and 16.47% as production forests that can be converted and 18.71% as non-forest areas, with details as follows:

KSA / KPA 1,630,828 Ha (10.38%) Protected Forest 1,346,066 Ha (8.62%) Limited Production Forest 3,317,461 Ha (21.55%) Production Forest = 3.881,817 Ha (24.99%) **Conversion Production Forest** = 2,543,535 Ha (16.47%) Other Use Areas 2,572,287 Ha (17.84%) = Waters 134,787 Ha (0.87%)

#### **Developments of the Forest Area Border Management**

1. Overall Boundary Length = 998 Km

• Outer Limit = 171,987 Km

• Function Limit = 826,017 Km

2. Realization of Boundary = 524 Km (16.82%)

3. Remaining Unregulated Zone = 474 Km (83.18%)

4. Width of Appointed Area = 149,801.86 Ha (30.26%)

#### **Changes in Functions and Lending-Using of Forest Areas**

#### 1. Release of Forest Area

• Legal basis:

Government Regulation No. 10 of Year 2010 jo. No. 60 of Year 2012 concerning Procedures for Changing the Allotment and Function of Forest Areas, arranged as follows:

- Changes in the allotment of forest areas are changes in forest areas to non-forest areas (Article 1 number 13 PP No. 10/2010).
- Exchange of forest area is a change in permanent production forest area and/or limited production forest to be non-forest area which is balanced by including replacement land from non-forest area into forest area (Minister of Forestry Regulation P.32 / Menhut-II / 2010 Jo. P.41 / 2012 Jo. P.27 / 2014)
- Release of forest area is a change in the allotment of production forest areas that can be converted into non-forest areas (*Minister of Forestry Regulation P.33 / Menhut-II / 2010 Jo. P.17 / 2011 Jo. P.44 / 2012 Jo. P.28 / 2014*).
- Release of forest area for the purpose of development outside forestry activities (Article 4 P.33 / 2010), including: placement of victims of natural disasters; reservoirs and dams; graveyard facilities; educational facilities; public safety facilities; public hospitals and health centers; government offices; housing and/or housing areas; transmigration; industrial buildings; harbor; airport; railway station; terminal; public market; regional development/expansion; food crop agriculture; agricultural cultivation; plantation; fishery; farms; or sports facilities.

## **Developments in the Release of Forest Areas**

Before SK 529/2012

• Plantation = 73 units = 677.53 ha

• Transmigration = 27 units = 113.81 ha

• Others (Land Reform Farmers)

• Mayor = 1 unit = 758.00 ha

After SK 529/2012

• Plantation = 57 units = 722.25 ha

• Transmigration = 3 units = 960.50 ha

#### 2. Lending-Using with Forest Areas

- Legal basis :
- Government Regulation No. 24 of Year 2010 jo No. 61 of 2012 concerning the Use of Forest Areas.
- Forestry Minister's Regulation Number P.16 / Menhut-II / 2014 concerning Lending and Using Guidelines for Regions.

• Development of Lending and Using of Forest Areas (*Izin Pinjam Pakai Kawasan Hutan/IPPKH*) for Mining Exploitation

The provision of 54 IPPKH permits with an area of 75,755.12 ha, detailed as follows:

• Number of IPPKH Coal Mining Exploitation = 48 units = 338.30 ha

• Number of IPPKH for the exploitation of gold mines = 3 units = 498.28 ha

• Number of IPPKH Oil and Gas Mining Exploitation = 1 unit = 41.80 ha

• Number of IPPKH Zircon Mining Exploitation = 2 units = 876.74 ha

### • Identification of Villages in Forest Areas

Based on the results of the identification of villages in the forest areas data, there were 308 villages in the forest areas, with details as follows:

1. Villages in the Conversion Production Forest areas = 169 villages

2. Villages within the HP / HPT / HL / KSA / KPA = 139 villages

In the framework of completion, 169 villages at HPK have been proposed for release to the Ministry of Environment and Forestry, while 139 villages in HP / HPT / HL, KSA / KPA will be processed through the IP4T Team.

# • Expansion of Community Management Areas

In order to expand the community management area, the Village/Urban Village Management Location in the Convertible Production Forest Area (*Hutan Produksi Konversi/HPK*) was established on the recommendation of Regency/City Government covering ± 624,101.04 ha in 377 villages through Governor Decree No. 188.43/301/2015 dated June 23, 2015 concerning the Establishment of Village/Urban Village Management Areas in Convertible Forest Areas (HPK) in Central Kalimantan Province.

Release has been proposed through a letter of the Governor of Central Kalimantan No. 522/0551/Dishut dated June 23, 2015 regarding the request for the release of the HPK areas for Community Management Areas, which is addressed to the Minister of LHK (cq. Head of BKPM).
